**NOTICE OF RACE**



**RULES:**

- The Organizing Authority is Coconut Grove Sailing Club and Snipe Fleet 7.
- The regatta will be governed by the rules as defined in the Racing Rules of Sailing ("RRS"), the current SCIRA Class Rules, By-Laws, and the Rules of Conduct for Conducting National and Local Regattas.
- US National Prescriptions shall apply except those pertaining to Rules 40 and 63.4.
- Racing Rule 63.7 is changed to provide that in the event of a conflict between the Notice of Race and the Sailing Instructions, the Sailing Instructions will prevail.
- The following Rules will be amended in the Sailing Instructions: RRS 27.1; RRS 30.3; RRS 32; RRS 33; RRS 35; RRS 61; RRS 62.2; RRS 66; RRS Appendix A2; RRS Appendix A4; RRS Appendix 4.2; RRS Appendix A5; RRS Appendix A11; ROC 5; ROC 8.1; and RRS Race Signals

**ADVERTISING:** Advertising is permitted as per snipe Class Rules. Boats may be required to display advertising chosen and supplied by the organizing authority.

**ELIGIBILITY**

**AND ENTRY:** The regatta is open to SCIRA registered boats and Class Member skippers who are in good standing with SCIRA for the current year subject to any Deed of Gift trophy restrictions.

**FEES:** The entry fee is \$100 USD. \$95 USD if US Sailing member. Registration and payment of entry fee must be completed no later than 0900 on March 19, 2015.
