**NOTICE OF RACE**



**RULES:**

- The Organizing Authority is Coconut Grove Sailing Club and Snipe Fleet 7.
- The regatta will be governed by the rules as defined in the Racing Rules of Sailing ("RRS"), the current SCIRA Class Rules, By-Laws, and the Rules of Conduct for Conducting National and Local Regattas.
- Racing Rule 63.7 is changed to provide that in the event of a conflict between the Notice of Race and the Sailing Instructions, the Sailing Instructions will prevail.
- The following Rules will be amended in the Sailing Instructions: RRS 27.1; RRS 30.3; RRS 32; RRS 33; RRS 35; RRS 61; RRS 62.2; RRS 66; RRS Appendixes A4, A4.1, A4.2, A5; Race Signals, ROC 5, and ROC 8.1.

**ADVERTISING:** Advertising is permitted as per snipe Class Rules. Boats may be required to display advertising chosen and supplied by the organizing authority.

**ELIGIBILITY  
AND ENTRY:**

The regatta is open to SCIRA registered boats and Class Member skippers and crew who are in good standing with SCIRA for the current year subject to any Deed of Gift trophy restrictions.

Boats shall enter the Regatta by going to the Regatta Network Website at <http://www.regattanetwork.com/event/4856> and completing the on-line Registration, including the fee section.

**FEES:** The entry fee is \$100 USD. \$95 USD if US Sailing member. Registration and payment of entry fee must be completed no later than 0900 on March 16, 2012.
