



EAST EUROPEAN CUP SNIPE CLASS 2020

07th-09th of August 2020 Jacht Klub Wielkopolski & SCIRA POLAND Kiekrz near Poznań - Poland

NOTICE OF RACE

1. ORGANIZING AUTHORITY

Jacht Klub Wielkopolski (Yacht Club of Great-Poland Region), Wilków Morskich Street 17/19, 60-480 Poznań in co-operation with the Polish Snipe Class Association - SCIRA POLAND.

2. RULES

2.1. The regatta will be governed by ISAF 2017-2020 Rules, the SCIRA Rules for Conducting National and International Championship Regattas, this Notice of the Race and Sailing Instruction.

3. ADVERTISING

Advertising shall be in accordance with ISAF Regulation 20 and SCIRA Advertising policy. The organizer shall determine the way of advertising on the boats.

4. ENTRY AND ELIGIBILITY

- 4.1. This regatta is open for the boats registered in SCIRA Poland or SCIRA and with paid fee for 2020.
- 4.2. Entry fee shall be paid.
- 4.3. Third party liability insurance with a minimum cover of EUR 2 000 000 shall be bought.
- 4.4. The valid PYA (PZZ) sailing license of each skipper and crew member for Polish participants shall be obtained.

5. **REGISTRATION**

- 5.1. Online registration for the Regatta on the basis of a print approved by WOZŻ (Great Poland Regional Sailing Association) available on the WOZŻ website, link http://wozz.poznan.pl/dokumenty/. , sent to the address jkw@jkw.poznan.pl by 06.08.2020. or in person at the regatta office on August 7, 2020. from 09.00 to 10.00 on the Regatta Registration form.
- 5.2. Registration for the event shall be completed on the following documents:
 - Completing the 'Regatta registration form'.
 - Entry fee in the amount of PLN 150 per boat, by bank transfer until 06/08/2020 (date of booking in the account of JKW) on account number: 84 1090 1362 0000 0001 0116 8312 Yacht Klub Wielkopolski, 60-480 Poznań, ul. Wilków Morskich 17/19 (payment title: PEW 2020 SNIPE, yacht number) or cash in the Club's box office every Monday from 13 to 19 or Wednesday, Friday from 17 to 20.
 - Making the required payment PLN 170 per boat at the day of the regatta at registration desk.
 - Valid third party liability insurance with a minimum cover of EUR 2 000 000.

6. **SCHEDULE**

07th of August 2020 from 9⁰⁰ to 10⁰⁰ Registration, Measurement.

7. RACING

07th of August 2020 – first race warning signal at 11²⁵.

08th of August 2020 – first race warning signal at 10⁵⁵

09th of August 2020 – first race warning signal at 10⁵⁵

On the last racing day no starting procedure will be started after 14⁰⁰, except following a previous General Recall.

8. **MEASUREMENT**

8.1. All boats are subject to measurement at any time at the reasonable discretion of the Race Committee.

9. SAILING INSTRUCTION

9.1. The regatta Sailing Instructions will be available during registration on 07th of August 2020 from 9⁰⁰ to 10⁰⁰ at the registration desk in Jacht Klub Wielkopolski and on the website www.snipe.com.pl and facebook Snipe Poland.

10. VENUE

- 10.1. Registration and measurement inspection will take place in the club house of Jacht Klub Wielkopolski.
- 10.2. Racing will be held in the waters of Kierskie lake at Kiekrz n/Poznan.
- 10.3. All accompanying events will take place at the grounds of Jacht Klub Wielkopolski.

11. PROTECTION OF IMAGE RIGHTS

By registration to the regatta, each participant consents to free of charge use of its image by the organizers and sponsors in the form of photos, movies and other materials created during the regatta and to its reproduction.

12. **SCORING**

- 12.1. The ISAF Low Point scoring system will be used.
- 12.2. When four (4) or fewer races are completed, a boat's series score will be the total of her races scores. No scores will be excluded.
- 12.3. When five (5) or more races are completed, a boat's series score will be the total of her races scored excluding her the worst score.
- 12.4. The final number of planned races and required minimum number of races to recognize the regatta as valid, will be given in Sailing Instruction.

13. PENALTY SYSTEM

According to the appendix P.

14. RADIO COMMUNICATION

- 14.1. Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats.
- 14.2. This restriction also applies to mobile phones.

15. **DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk and liability. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta. None of the activities performed or not performed by the organizers do not exempt the participants of the regatta from being liable for material damage, bodily injury or death arising in connection with the period before the regatta during the regatta and after the regatta.

The Registration of the participation in the regatta shall constitute the acknowledgement and approval of hereby Notice of Race and acceptance of its provisions by the skipper and the crew of the boat.

The skipper is obliged to sail the boat personally.

16. **PRIZES**

Prizes will be awarded to the top three (3) classified teams in open East European Cup.

17. GENERAL INFORMATION

The closing ceremony of the Regatta and the awarding of prizes will be held on August 9, 2020 at 4:00 p.m. at the premises of the Yacht Club of Wielkopolska.

Information about the meetings accompanying the regatta will be given by the organizer in a separate message.
