



NOTICE OF RACE

For The GRAND PRIX MIXED Trophy
Agost 21th & 22th, 2021

1. ORGANIZING AUTHORITY

REAL CLUB NÁUTICO DE MOTRIL in cooperation with Snipe Fleet 69 and Snipe Class International Racing Association "SCIRA".

2. HOST CLUB AND FLEET

Real Club Náutico de Motril and Real Club Náutico de Motril Snipe Fleet 69, international 624

3. RULES

3.1 The regatta will be governed by the rules as defined in the Racing Rules of Sailing ("RRS") 2020-2024, the SCIRA Rules of Conduct for Conducting National and International Championship Regattas, the Deed of Gift for the GRAND PRIX MIXED Trophy. 9.1

3.2 No national prescriptions will apply. 9.1

3.3 Appendix P will apply. 9.1

3.4 RRS 35 will be changed to provide that boats not finishing within 30 minutes after the first boat to finish will be scored "Did Not Finish" without a hearing. 10.2

3.5 RRS 62.2 and 66 will be changed to shorten the time for requesting redress and the requesting that a hearing be reopened on the last day of racing. 11.1

3.6 RRS 30.3 will not be used. 11.1

3.7 RRS 30.2 and 33 will be changed to limit course changes 11.1

3.8 RRS 60.1(a) will be changed to restrict protest from boats for specific items on the NoR and SI. 12.1

3.9 Racing Rule 63.7 will be changed to provide that in the event of a conflict between the NOR and the Sailing Instructions, the Sailing Instructions will prevail. 12.1

3.10 Appendix A will be changed to not exclude races in the serie's score. 12.1

3.11 If there is a conflict between languages the English text will take precedence. 14.1

3.12 Crew change within the boat is allowed at any time. 14.1

4. ADVERTISING

4.1 Boats may be required to display advertising chosen and supplied by the organizing authority. 15.1

5. ELIGIBILITY & ENTRY

5.1 This regatta is open to SCIRA registered boats and Class Member skippers and crews mix who are in good standing with SCIRA for the current year. 15.1

5.2 Eligible competitors shall entry to SAILTI regatas.realclubnauticomotril.es up to 1800 of AGOST 2th, 2021. Event-pack basic: 50€ 15.1

5.3 All entrants are required to complete the onsite registration/check-in process by 1000, Saturday, Agost 21th, 2021. 15.1

6. SCHEDULE

6.1 Registration/Check-in 15.1

Friday, Agost, 20th 2020: 0900 to 1800

Saturday, Agost 21th 2020: 0900 to 1000

Racing

Saturday, Agost, 21th 2020: Warning Signal First Race at 12:00h

Sunday, Agost, 22st 2020: Warning Signal First Race at 11:30h

On the last day of the regatta, no warning signal will be made after 16:00.

6 races are scheduled of which 2 must be completed so that the championship is valid.

7. SAILING INSTRUCTIONS

Sailing Instructions will be available at on-site registration/check-in on Agost 20th, 2021.

8. VENUE

The racing venue will be the area known as Motril Bay in the Mediterranean Sea off Motril.

9. COURSES

The courses to be sailed are depending on local weather conditions.

10. SCORING

One (1) races constitutes a regatta.

A boat serie's score there will be no discard.

11. INSURANCE

Each non spanish participating boat shall be insured with valid third-party liability insurance with a minimum cover of €300.500, 00 or the equivalent.

12. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See Rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

13. PRIZES

One division of medals will be presented for top five places.

14. SOCIAL

Prize giving Ceremony scheduled for Sunday afternoon, Agost 22st 2021, subsequent to the races. 17:00h (approximately)
