Submerged Rules

Ambiguity in the Sailing Instructions

"The Race Committee saw Star#3235 sail under a sidespan of the Captree Bridge instead of the center span as a majority thought the sailing instructions provided and. . . ". The previous sentence is quoted from Appeal #66. It seems that the intent of the Race Committee was that yachts should sail through the center span. Indeed, for most of the classes in this multiclass regatta the sailing instructions so stated. Yet for the Star class the course was not printed in the sailing instructions. They did state, however, that the marks to be passed would be signalled from the Committee Boat. The center span of the bridge was not included in the list of marks actually signalled from the Committee Boat.

Prior to the race, the skipper of Star

#3235 asked if there was any rule which required him to pass through the center span. The response from a member of the Race Committee was, "No, but I certainly advise against a shallower, lower span." Apparently Star #3235 ignored this friendly suggestion and was observed sailing under a sidespan.

The Race Committee disqualified Star #3235 ruling that "The offhand advice from a member of the Committee during the period shortly before the start of a regatta was obviously not intended to be a ruling and does not bind the Committee." This is consistent with other rulings by the Appeals committee and would undoubtedly have been binding if there were no extenuating circumstances.

The Appeals Committee ruled, however, that there was reasonable doubt as to whether or not the center span ranked as a mark for the Star Class. They continued giving us another Submerged Rule as follows: "When a reasonable doubt exists as to an interpretation of a sailing instruction, it must be resolved in favor of the contestant even though he was the only one to take advantage of it."

Experience indicates that few Race Committees know this Submerged Rule. Invariably, when confronted with ambiguity, they rule in favor of what was intended by the Race Committee. Consequently, you might want to remember this Submerged Rule and the Appeal from which it comes so that you can call it to the attention of some future Race Committee in the event you either accidentally or with clever preplanning profit from ambiguity in the sailing instructions.

THE SCORE

Thirty-one numbers were issued during the month with 20 going to Spain, 10 to Argentina and 1 to Uruguay. No new fleets were chartered.

SCIRA/US Board Meets at Detroit, August 11, 1985

PRESENT: Ralph Swanson, U.S. National Secretary, Rules Committee Chairman Ted Wells, Rules Vice-chairman Dan Williams, Rear Commodore Jerry Thompson, Executive Secretary Buzz Lamb, Members-at-Large: Sam Mollet, Larry White, Means Davis, Dick Schmidt, and Fritz Gram; District Governors Patti Fisher and Jeff Lenhart.

Secretary Swanson announced that some of the agenda items would be taken out of order.

MINUTES: It was moved, seconded and passed that the minutes of the previous meeting be accepted as published in the October 1984 issue of the *Bulletin*.

FINANCIAL REPORT: SCIRA/US Fund cash receipts and cash disbursements, and cash balances for the first six months of 1985 were presented. Discussion followed on collection of outstanding charges on return shipment of boats from Portugal. Money for one boat has been recouped. Invoices will be sent for the others. Without travel expenses the U.S. Fund would have no problem. Reallocation of SCIRA office expenses between SCIRA/International and SCIRA/US was discussed as a means for a better balance. Currently salaries are divided equally between the two. Swanson discussed the background of this split.

Davis asked about the make-up and authority of the US Board. Swanson stated that there is no constitution for the US Board which conducts US affairs. By tradition, those members of the international board who reside in the US constitute the US Board. District Governors are invited to attend for information and input, but not as voting members.

USISA through USYRU has made a travel grant to those competing in the Worlds, in the amount of \$2,400, but has specified that grants may not go to those in the marine trades, or those who can deduct expenses from income tax payments. The money may otherwise be divided among those eligible as the class sees fit.

PRESENTATION US NATIONALS BID 1988: Warren Wheaton presented a slide show of the San Francisco and Richmond Y.C. area as a bid for the 1988 US Nationals. Either District 6 or District 7 will be approved as host district. Wheaton also asked the Board to consider an increase in the entry fee for the US Nationals

and an increase in the number of entries allowed for the host club.

VICE-SEC./WH BOARD POSITION: A Constitutional amendment proposed to add the Vice Secretary of the Western Hemisphere as a voting member of the Board. An additional proposal was made to drop the Secretary of Eastern Europe as a board position. Background of the addition which would balance the Vice Secretary of Europe already on the Board; and the deletion as the position no longer has nations associated with SCIRA and would also maintain the same number of members on the Board, was given by Swanson. Both proposals were moved, seconded, discussed and passed. (This vote is advisory only as this is to be voted on by the International Board in November.)

AMENDMENTS TO DEEDS OF GIFT: Hub Isaacks Trophy: A proposal for changing the number of entries in the deed of gift to a "pro-rata" basis, based on the number of registered Snipes in a nation. It was moved, seconded and passed that this proposal be accepted. (This vote is advisory only as this is to be voted on by the International Board in November.)

Masters Trophy: Changes proposed by the donor, Dan Blodgett: Minimum age for a skipper changed to 45; minimum combined ages of skipper and crew shall be 80; skipper and crew may change places from race to race but only if both are SCIRA members and both meet age requirements. After discussion a further change was proposed which would "grandfather" those between the ages of 40 and 45 who have already sailed in a Masters Championship. Changes moved and seconded but resulted in a tie vote. The deed of gift requires agreement between donor and SCIRA; the donor will make the binding decision on changes.

ONE BOAT FOR ALL: Don Hite has made seven video copies of the film which will be presented to the districts. He is willing to compile a new video movie from regatta footage sent to him. An announcement will be put in the *Bulletin* asking for submissions for the film.

HEINZERLING TROPHY: The trophy needs room for more names. Repairs approved.

PAN AM GAMES: Lamb reported that sailing for the 1987 Pan Ams will be at Michigan City, IN. Decision on classes is to be made by a committee constituted at the last games in Venezuela. USYRU President Chuck Kober and Tom Ehman are understood to be on the committee. Probable classes are J-24, Star, Lightning, Snipe, Laser, and a sailboard. Bill Lynn

will be the new USYRU president (he owns a Snipe.) Swanson urged all members to use their influence to have Snipe included. The U.S. will be committed to lend boats to be chartered to contestants who do not bring their own boats. This will require a maximum of 18-20 boats.

WORLD CHAMPIONSHIPS: Argentina will lend one boat for each nation; a second one will be available for charter.

REGATTA PRIZES/AMATEUR STATUS: Consideration was given the question of a Snipe given as a regatta first award. It was decided this is in excess of what is allowed under the rules, and thus endangers the amateur status of the contestants.

CHAMPIONSHIP SITES: North Americans 1986 — San Francisco will be host. Gram wants to submit a bid for Buffalo Canoe Club to hold the North Americans and asked where to submit bids. Swanson stated that bids are submitted to the U.S. National Secretary, and the decision is made between the secretaries of the U.S., Canada, Bermuda, and the Bahamas. Masters 1986 — Bids were presented for Indianapolis and Atlanta. Atlanta's bid was accepted for 1986. Indianapolis was chosen for 1987 if they so wish. U.S. National 1986 - District 5 and Chautauqua Lake Fleet 124 will be hosts for the regatta which is scheduled for late July 1986. U.S. Nationals 1988 — District 6 or 7 will host the nationals that year. San Francisco (D-7) has submitted a bid. Mission Bay (D-6) may also submit a bid. Bids will be accepted up to January 1, 1986 for that championship.

ENTRY FEE FOR U.S. NATIONALS: Moved and seconded that the entry fee be raised to \$100. After discussion, the motion failed to pass. Moved and seconded that the fee be increased to \$75. Passed.

INCREASED ENTRIES FOR CROSBYS: Moved and seconded that the host fleet for the U.S. National be given an increased quota of 2 boats for 5 registered Snipes. Passed. Moved, seconded and passed that district qualifers for the Crosbys be changed to "drop down" if the second and/or third place finishers do not attend. This is to be accomplished by deleting the words "no alternates" in the "OPEN TO" section on page 127 of the current SCIRA Rule Book.

FINANCES: There was a discussion of travel allocations. It was moved, seconded and passed that there be no travel allowances other than those funds provided by the USISA.

MEASUREMENT AND RULES: Williams reported that 3 major builders had submitted samples of the hull material of their boats. Klegecell is used by all, making for a much stronger boat. He has talked to all builders during the measurement process at the nationals. Measurement at this regatta has gone well.

SAILING INSTRUCTIONS, CUR-RENT CHAMPIONSHIP: There was discussion of the one-minute and the threeminute sudden death rule included in the sailing instructions submitted for this regatta. SCIRA has a set of required sailing instructions in the current Rule Book. The decision was made that the instructions must follow the SCIRA Rule Book.

ORGANIZATION: Davis discussed the codification of rules and by-laws for the U.S. organization. It was moved, seconded and passed that he be asked to consider and submit such rules and by-laws. Gram and Thompson will assist.

Meeting adjourned.

General Membership Meeting Held

The U.S. General Membership meeting was called to order by Ralph Swanson, U.S. National Secretary, at 4:15 p.m. August 16 at Crescent Sail Yacht Club, Detroit, Michigan.

Secretary Swanson introduced other members of the board including: Jerry Thompson, Sam Mollet, Fritz Gram, and Means Davis. Actions taken by the U.S. Board at their all-day meeting on Sunday were reviewed: The U.S. Board of Governors will not fund travel in 1985. The USISA has granted \$2,400 in travel funds. Charter and loaner boats are available in Argentina for the worlds, and SCIRA/US will not fund boat shipment.

Other actions and votes by the U.S. Board were reviewed. (See minutes of the Board Meeting).

Announcement was made of the dates selected for future championships, the changes in the deed of gift for the U.S. Masters, and the change in entry fee for the future U.S. Nationals.

The meeting was then thrown open for questions and discussion: Ron Fox asked about funding for travel from the USISA. The grant may be split in any way between those eligible, as long as the person receiving a grant is not in the marine trades.

Other questions were asked on increasing funding for the U.S./SCIRA treasury. Increase in royalty fees was suggested. Allocation of salary contribution between SCIRA international and SCIRA/US discussed. Currently the split is 50/50. Reapportionment would substantially ease the financial burden on the U.S. treasury. Financial statements are sent to members of the board and district governors. They are not printed in the Snipe Bulletin. Gonzo Diaz proposed a financial committee for the U.S.

Means Davis who will be chairman of a committee to undertake a study of the bylaws invited people to submit ideas for consideration.

Swanson discussed a downturn in onedesign sailing and requested people publicize their regattas more fully. He expressed his thanks to the board who had spent their time on the all-day board meeting. With travel costs skyrocketing, he also expressed thanks to Larry White, Dan Williams, and Ted Wells, who attended the meeting although they did not plan to sail in the regatta.

Further discussion included the following questions: Bill Buckles asked about the term of office for the Board. Brian Mollet suggested that donations which are tax deductible be requested in the Bulletin. Lee Griffith asked if it would be possible to allow late-registration for the nationals with a large late registration fee. Gonzalo Diaz asked if there is a refund of the Nationals registration fee. Answer, "Yes, if the request is made before the start of racing.

Bob Hill expressed appreciation to Ralph, Buzz, and the Board for the work for the class.

Meeting adjourned.

District IV Title Copped by Pritchard

David Pritchard and Mike Lenkite of the Lake Lanier Fleet won the SCIRA District IV Championship held June 23-24 on Chickamauga Lake. Privateer Fleet 142 was host to the 51 boat fleet which included representatives from 11 of the 13 fleets in the District. Tarasa Davis and crew Steve Sammons repeated as District IV Junior Champion.

Means and Peggy Davis, representing both Atlanta Yacht Club and the Barefoot Fleet, were second. Mike and Marsi McLaughlin and Pete and Jean Duvoisin from the host club took third and fourth place honors. Raymond Burke and Robb Ostrom of Lake Lanier were fifth.

Only four of the scheduled five races were completed.

In spite of surprisingly good winds for the first and second races on Saturday, starts were complicated by a big fleet and shifting winds, resulting in time wasting recalls, and only two races were completed the first day. Positions were scrambled by a wind shift on the finishing leg of the first race, with Woody Norwood of Atlanta nipping Gonzalo Diaz, Sr., for first place. Brent McKenzie of Lake Lanier was third. The start of the second race was delayed while a string of barges passed through the course, and a lunch break was declared before the second start.

The wind continued shifty for the second

race, but the predicted thunder storms never materialized. David Pritchard worked out a comfortable lead, and won the second race easily. Mike McLaughlin and Means Davis took the second and third place spots.

Sunday morning's first race was again delayed by one false start and a recall, but by the second start the wind had died to drifting conditions, and *nobody* was at the line when the gun went. A drifting first triangle ended when the wind came from behind, taking most of the 50 boat fleet around the leeward mark together in one blob. When all was sorted out Dave Pritchard got his second bullet with Don Pettigrew of AYC second, and Means Davis again in third place.

The wind settled in enough for a fourth race to be sailed back-to-back with the third. Pritchard worked out a horizon job, to take the race and the regatta. Buzzy and Gail Heausler of the Clearwater fleet were second, and Means Davis had his third third place finish.

Engraved brass ship's bells were the unique trophies awarded for the first five places, and the Seavy-Roberts perpetual District IV Trophy went to a new winner: Dave Pritchard who is in his third year as a Snipe sailor.

Scott Cline was regatta chairman. District Governor Frank Pontious presided over the district meeting held on Saturday night.





HEINZERLING TROPHY

Wednesday began with thunderstorms and a one hour postponement after the championship series skipper's meeting. When the fleet finally got out to the race course there was only time to finish one race before the thunderstorms rolled in again. The light air race featured an all California top four with Jim Grubbs of San Francisco first, Jack Franco second, Warren Wheaton, also of San Francisco third, Steve Rosenberg fourth, with the first non-Californian being Dave Pritchard of Atlanta in fifth.

With only one race completed going into Thursday, the committee was praying for wind and the possibility of getting in three races. Wind was what they got, along with a driving cold rain which persisted almost all day and at times made even the big inflatable marks hard to find. The Heinzerling race committee did an excellent job in getting three good races in without much delay in between. The fleet was divided after race two between those who wanted to go in and get warm, and those who couldn't stand to see such good wind wasted. The committee sided with the latter and race three was started promptly. Keith Dodson proved that the Californians can hang in there in our cold northern summer by taking a first. Ed Adams finished a good day by placing second with Steve Callison coming back from an 18th the race before to take third. Disaster struck some of the stars of the fleet though as Lenhart and Reynolds finished 30th and 31st respectively.

Friday's final race began in light winds with Jack Franco holding what seemed to be a solid 10 point lead on Steve Rosenberg. It was not to be however, when Jack finished 14th with Rosenberg coming in third to take the series by a point. Race five was won by Fred Rozelle of Crescent who chipped away at the leaders the whole race and took the lead on the final beat. Steve Callison's second locked up a series third.

WELLS TROPHY

In the Wells, consistency paid off for Means and Peggy Davis whose score included only one race worse than fourth (a seventh). Race one Wednesday saw a post-

A race was started in about five knots of wind and some of the flattest water we saw all week. Bill Buckles led this race all the way around to the leeward leg where John Irvine got past him, only to be passed himself by Mark Zonnenberg of Lake Lanier on the final beat. Irvine finished second, Davis third, Buckles fourth.

Thursday's rotten weather took its toll on the Wells fleet, with more than one boat deciding that two races was enough for one day and skipping number three to go take a hot shower. The first race Thursday saw Dick Hand of Portage Lakes take an early lead, only to have Bill Buckles sneak by on the second beat. Buckles hung on to win followed by Hand in second and Leigh Savage of Crescent in third.

In Thursday's second race it was John Irvine of Cowan Lake who took control, winning going away with Charlie Bustamante of Miami, second and Means Davis third. Bob Rowland of Cowan came from behind on the final beat to take fourth place in a race which saw the fourth through 11th place boats finishing within 20 seconds.

Thursday's final race (with a smaller fleet hanging in there) belonged to John Irvine again. This time, Bill Buckles chased him around the course for a second with Jim Evans of Lorain third, Means Davis fourth and Leigh Savage fifth.

Davis went into Friday's final race with a slim, ¾ point lead over Buckles and only 2½ over Irvine. Disaster seemed to strike when he rounded the weather mark in the twenties. What followed was a display of light air mastery that I'm sure Buckles and Irvine won't soon forget. Means worked his way to second behind Bob Rowland to win the series and the Wells Trophy. Charlie Bustamante was third in the final race with Irvine and Buckles fourth and fifth respectively.

This year's nationals was noteworthy because of a total lack of protests between competitors out on the water. It is a tribute to the Snipe Class and its sailors that such a talented group of competitors could participate in such tight racing for a full week with no unsettled disputes being brought in off the course. These sailors race as ladies and gentlemen according to the rules and should be proud of themselves. This, along with everything else that Snipe sailors bring with them to a regatta make all of us at Crescent very proud and honored to have been able to host the 1985 U.S. Nationals. Leigh Savage

The Carolyn Nute Memorial Trophy for the top finishing husband and wife team went to Fred and Jan Rozelle.





Wolstenholm Is British **National Victor**

The UK Snipe Nationals drew a fleet of 28 boats, including competitors racing from Gryon S.C. Switzerland and Alamitos Bay Y.C. America. Raced over neutral waters, in the Thames Estury, at the Sheppey Y.C. Sheerness. With the Association supplying the race officers, course laying and rescue coxswains the now familiar 'Snipe traveling circus' arrived on the Thursday evening of July 11 to put together the final touches for a problem free championship.

With the morning briefing, on Friday, competitors prepared for the first race at noon. True to schedule at the stroke of midday the flags were dropped, the cannon fired and the fleet got away to a clear start with helms G. Lewis, T. Stratham, P. Mason leading the fleet. But, by the time the first mark was reached on the Olympic course much had changed and encouraging to see two junior helms A. Lewin and M. Lawry coming well up. Final positions for the first race went to A. Stratham, A. Lewin, P. Mason and G. Lewis forth.

The second race followed in the afternoon with a wind picking up to a force three. From the start there was no question of the winner; Paul Mason took a magnificant lead which was held until the final cannon signalled his winning race two. Two Budworth fleet Snipes took second and third with A. Stratham and Alan Williams. That evening at the Commodores Reception, a happy party got underway with a barbecue cooking well into the late evening rounding off a perfect day.

Lewin winning and gaining much applause from the committee boat for their excellent sailing in tough conditions. Cheers also went to the other two junior crews M. Lawry from Stone S.C. and Ian Harding, Broadstairs S.C. whom were well up.

To complete the second day of racing a German Evening packed out the host club. With a German band supplying the music/cabaret and traditional larger being sold at half price many heads were drumming the following morning!

Day three dawned with heavy winds that had arrived overnight with a frightening thunder storm. Many anxious eyes turned to the wind indicator then to the sea running. The gorilla type crews looked with glee, whilst those with less bulk pondered. In a force six the race got underway with junior M. Lawry first at the mark. The tough conditions spread the fleet whilst capsizes put many out, unfortunately M. Lawry/P. Blud became victims whilst in a strong challenging position. Race five went to A. Williams, P. Wolstenholm and G. Lewis.

With the weather deteriorating the final race got off without delay with only half the fleet entering. With exciting racing the race went to A. Stratham representing the Budworth fleet.

A dazzling show of trophies was laid out for presentation, many of the perpetual cups of solid silver dating back to the mid 1930s.
