### **1 RULES**

- 1.1 The regatta will be governed by the Rules as defined by the World Sailing (WS) Regatta Rules (RRS)
- 1.2 The SNIPE class Rules (SCIRA) for conducting International and National championship regattas (Rules of Conduct for conducting International & National championships).
- 1.3 Rule 35 of the RRS will be modified to provide that boats that do not finish the race within 30 minutes from the first boat will be classified DNF without a hearing.
- 1.4 Rules 62.2 and 66 of the RRS will be modified to limit, on the last day of the race, the time for submitting requests for redress or for reopening a hearing.
- 1.5 Rule 30.4 (Black flag) of the RRS will be used in case of fleets with more than 45 boats and after the second general recall.
- 1.6 In the event of a conflict between the Notice of Race and the Sailing Instructions, the Sailing Instructions will take precedence (amendment RRS 63.7).

### **2 ADVERTISING**

- 2.1 Advertising is permitted in accordance with WS Regulation 20.
- 2.2 Boats may be requested to display advertising chosen and supplied by the organizing authority

### **3 ENTRY AND ELIGIBILITY**

- 3.1 Competitors in compliance with the new WORLD SAILING Eligibility code in force may take part in the regattas.
- 3.2 Italian competitors must possess the FIV card for the current year, filled in for the part relating to the medical examination and the SCIRA card valid for 2023.
- 3.3 Foreign competitors must comply with the prescriptions of their National Authority relating to participation in regattas and the SCIRA membership for 2023.
- 3.4 As per FIV regulations, eligible boats can register for the regatta from 01.08.2023 until 24.00hrs on 17.08.2023 on the Fiv Portal at the link <https://federvela.coninet.it/> (for Italian crews) or on RRS at the link <https://tinyurl.com/2xzbv62f> (for foreign crews) by simultaneously paying the entry fee, the receipt of which must be sent to [iscrizioni@centomiglia.it](mailto:iscrizioni@centomiglia.it)
- 3.5 The entry fee is €60.00 and includes regattas and events. As per FIV regulations, any late registrations after 17.08.2023 will be increased by 50%. Registrations will close on 18.08.2023 at 12.00hrs.
- 3.6 The registration fee as in point 3.5 must be paid by bank transfer to **Banca Intesa IT38J030695531110000000569 (ISP); Bic: BCITITMM** or at the Regatta Office in cash or by debit/credit card.

#### **4. SCHEDULE**

- 4.1 Skipper Meeting: Saturday 19.08.2023 at 11.00.
- 4.2 Races: a total of 4 races will be sailed; no more than two races will be sailed per day except in case of recovery of lost races.  
The scheduled time for the warning signal of the first race on Saturday 19.08.2023 is at 13.00hrs. The timetable for the first race on Sunday 20.08.2023 will be published on the bulletin board by 8.00 pm of the previous day. In the last day of the race no warning signals will be given after 16.00.

#### **5. EQUIPMENT INSPECTION**

- 5.1 The boats must possess a valid and complete measurement certificate and display the decal attesting the SCIRA association for the current year. The measurement certificate must be uploaded to the FIV Portal or sent to iscrizioni@centomiglia.it
- 5.2 Boats may be subject to measurement inspections at any time during the event, at the discretion of the Race Committee or the SCIRA measurer.

#### **6. SAILING INSTRUCTIONS**

- 6.1 The sailing instructions will be available from 9.00hrs on Saturday 19.08.2023 on the FIV Portal and on RRS.

#### **7. VENUE**

- 7.1 The regattas will take place in the waters in front of Gargnano.

#### **8. COURSES**

- 8.1 The courses to be sailed are the Class approved courses as published in the SCIRA web site.

#### **9. SCORING**

- 9.1 The regatta consists of a series of 4 races and will be valid with any number of races. If 4 races are completed, the worst race will be excluded.

#### **10. RADIO COMMUNICATIONS**

- 10.1 Except in an emergency, a boat racing shall not make radio transmissions and receive communications not accessible to all other boats. This provision also applies to mobile phones.

#### **11. PRIZES**

- 11.1 Prizes will be awarded to the first three boats in the final standings.

#### **12. RISK STATEMENT**

- 12.1 Competitors take part in the regatta at their own risk (see RRS 4 - Decision to Race). The Organizing Authority, the Regatta Committee and the Snipe Class Association (SCIRA) will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

#### **13. ENVIRONMENTAL RESPONSIBILITY**

- 13.1 Recalling the Basic Principle which states: "Participants are encouraged to minimize any negative environmental impact of the sport of sailing", the utmost attention to environmental protection is recommended in all moments that accompany the practice of the sport of sailing before, during and after the races. In particular, attention is drawn to RRS 47 – Disposal of Waste – which states: "Competitors and support persons must not deliberately throw waste into the water. This rule always applies when in the water. The penalty for a breach of this rule may be less than disqualification."

#### **14. INSURANCE**

- 14.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of € 1.500.000 per incident or the equivalent, or be in possession of the FIV PLUS Card. The certificate of validity of the insurance must be uploaded to the FIV Portal or sent by email to iscrizioni@centomiglia.it

**15. DATA PROTECTION AND RIGHTS TO USE NAME AND LIKENESS**

15.1 By participating in this event, competitors automatically grant to SCIRA, the organizing authority and the event sponsors the right, in perpetuity, to make, use, and show, at their discretion, any photography, audio and video recording, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

**16. SOCIALS**
