ENTRY & ELIGIBILITY

All skippers shall be citizens or residents for at least one year of the country they represent and each must present credentials signed by the National Secretary from the country he/she represents attesting that he/she is the entrant.

OPEN TO

- 1. Any SCIRA member for the year of the Championship.
- The following formula shall be used. Registered Boats means number of paid and properly registered boats with SCIRA. The information for a properly registered boat must include: name of the owner, address, fleet, country and hull number.

- 3. Additional entries, not included in the above quota:
 - (a) Any former Hub E. Isaacks World Champion skipper

And also the current:

- (b) European Champion skipper.
- (c) Western Hemisphere & Asia Champion skipper.
- (d) Women's World Champion skipper.
- (e) First and second place skippers in the Junior World Championship will qualify for the following senior World Championship of SCIRA.
- (f) One additional skipper from the host country.
- (g) One additional skipper from the host fleet.
- 4. Reallocated entrants will not count against, nor limit, the initial per country allocation.

REGISTRATION & UNASSIGNED ENTRY SLOTS

- 1. The Notice of Race will be posted at least six months before the first day scheduled for measurement.
- 2. The registration period starts with the posting of the Notice of Race and ends a minimum of 90 days prior to the first day scheduled for equipment inspection.
- 3. The unassigned entry slots are defined as the difference of valid entrants at the close of the initial registration period from the maximum number of 80 boats.
- 4. If, 90 days prior to the first day scheduled for equipment inspection, the number of entries does not meet 80 boats:
 - (a) Unfilled entry slots will be re-allocated to a pool of qualified entrants, as provided below.
 - (b) SCIRA shall post to the Official Regatta Website the number of entries available and the assigned pro-ration of these entry slots to those countries which have registered entries and fulfilled its allotment during the initial registration period. The allocation will be posted within 7 days after the conclusion of the initial registration period and countries will then have, from the time of the posting, until 60 days prior to the first day scheduled for equipment inspections to register additional entries.

5. Any reallocation entry not filled by a country 60 days prior to the regatta first day scheduled for measurements, will then be made available on a "first come" basis only from received valid registration applications to SCIRA.

REGATTA CONDITIONS

- 1. The title is subject to WS approval under Regulation 12.
- 2. Held every two years as scheduled at the venue selected by the Voting Members of the SCIRA Board of Governors.
- 3. Nine (9) races of the official SCIRA courses shall be scheduled.
- 4. The Notice of Race shall include the following:
 - The Rules of Conduct for National and International Championships will apply.
 - (b) The Deed of Gift for the Commodore Hub E. Isaacks Trophy will apply.
 - The Deed of Gift for the Bib Juetz Perpetual Trophy will apply. (c)
 - (d) The Deed of Gift for the Earl Elms Perpetual Trophy will apply.
 - The Deed of Gift for the O'Leary Trophy will apply.
 - When less than seven (7) races are scored, a boat's series score will be the total of her race scores. When seven (7) or more races are scored, a boat's series score will be the total of her race scores excluding her worst eligible score.
- 5. There must be a separate Race Committee and Protest Committee.
- 6. The SCIRA Chief Measurer or a WS International Measurer shall be the chief of the Measurement Committee.
- 7. The Organizing Authority of the Regatta must provide an adequate number of equally matched boats with good racing capability to loan or charter to competitors who do not bring their own boats.

LANGUAGE

The official language shall be English. The use of other languages, as secondary, can be the prerogative of the Organizing Authority and shall not be used for Official Communications with competitors by the Committees or Organizing Authority.

TROPHY RESPONSABILITY

The trophy is the responsibility of the Fleet of the winning skipper. The fleet shall see that the trophy is taken care of, guarded and returned to the place designated for the next competition, properly boxed for shipment with all duties and other charges paid by the Fleet. The name of the winning skipper and crew, year, fleet and country shall be engraved at the winner's expense in uniform engraving.
