REGATTA CONDITIONS

- 1. Held every year in a South European country.
- 2. 4 races (in case of 2-day regatta) or 6 races (in case of a 3-day regatta) shall be scheduled.
- 3. The Championship shall be sailed in waters selected by the European National Secretaries.
- 4. There must be a separate Race Committee and Protest Committee.
- 5. The Notice of Race shall include the following:
 - (a) The Rules of Conduct for National and International Championship will apply,
 - (b) The Deed of Gift for the Sergio Michel Perpetual Trophy South European Championship will apply
 - (c) In a 3-day regatta, when less than five (5) races are completed, a boat's series score will be the total of her race scores. When five (5) or more races are completed, a boat's series score will be the total of her race scores excluding her worst score.
 - (d) In a 2-days regatta, when 4 races are completed, the worst race shall be excluded.
 - (e) 2 races shall constitute the regatta.

LANGUAGE

The official language shall be English. The use of other languages, as secondary, can be the prerogative of the Organizing Authority and shall not be used for Official Communications with competitors from the Committees or Organizing Authority.

TROPHY RESPONSIBILITY

The winning team is responsible for engraving and safekeeping of the trophy, and return to the regatta the following year. A non-perpetual trophy may be awarded to the winning team not in condition to return the Trophy.
